**PRIMARY TRANSMITTERS: TELEVISION**

**SPECIAL STATEMENT CONCERNING GROSS RECEIPTS EXCLUSIONS**  
 The Satellite Home Viewer Act of 1988 amended Title 17, section 111(d)(1)(A), of the Copyright Act by adding the following sentence:
