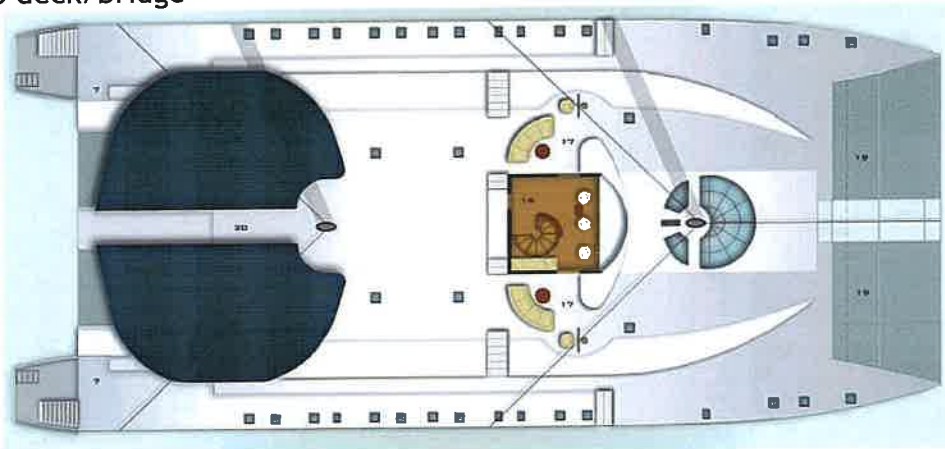

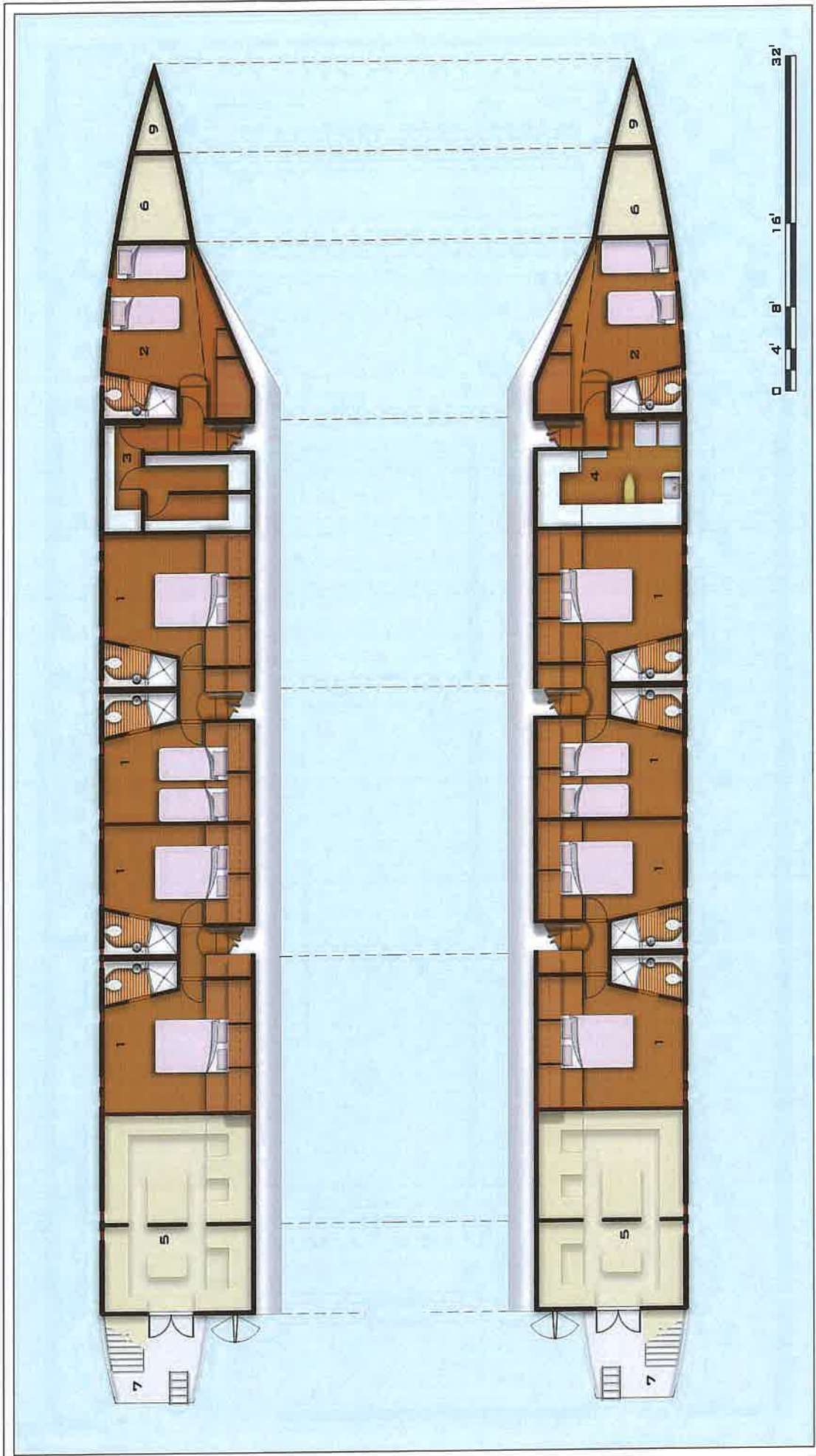

Elevation

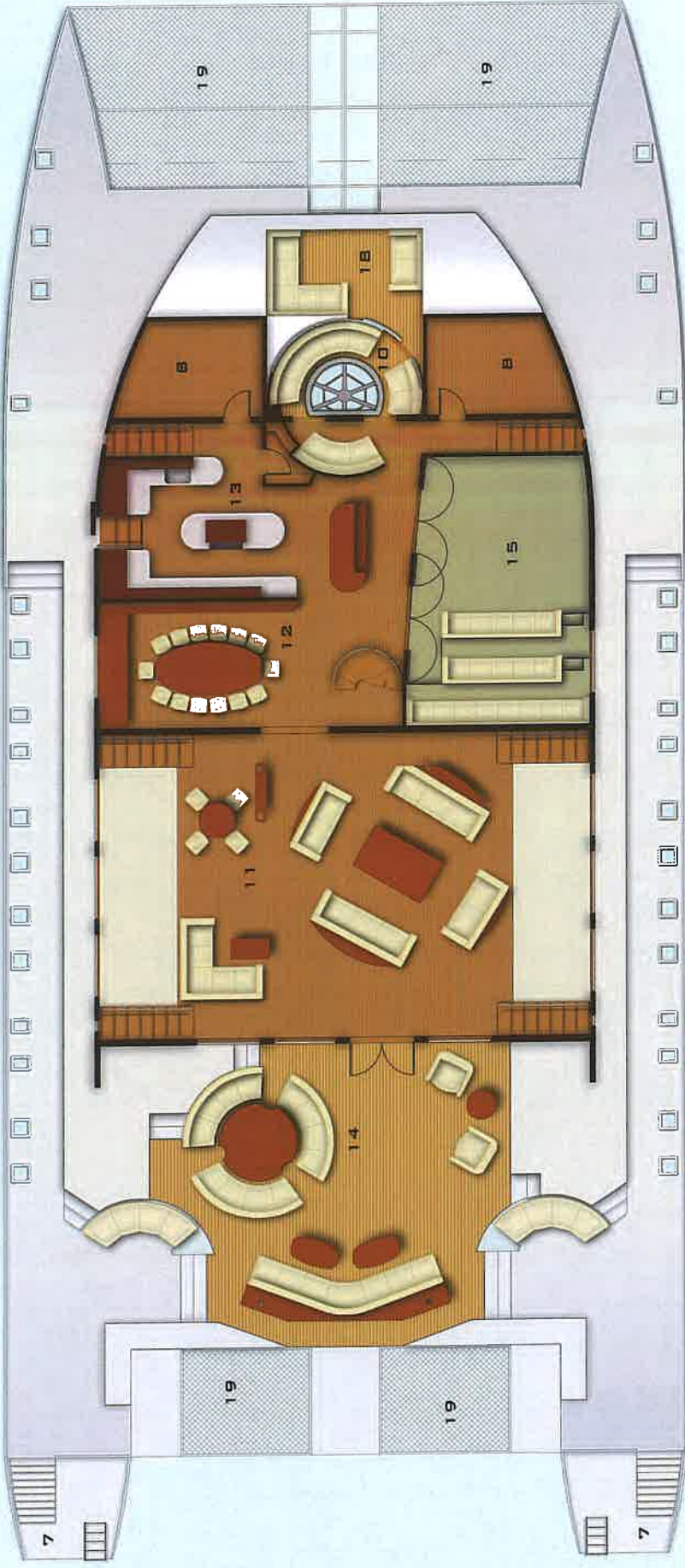


P A R C A S 1 2 0

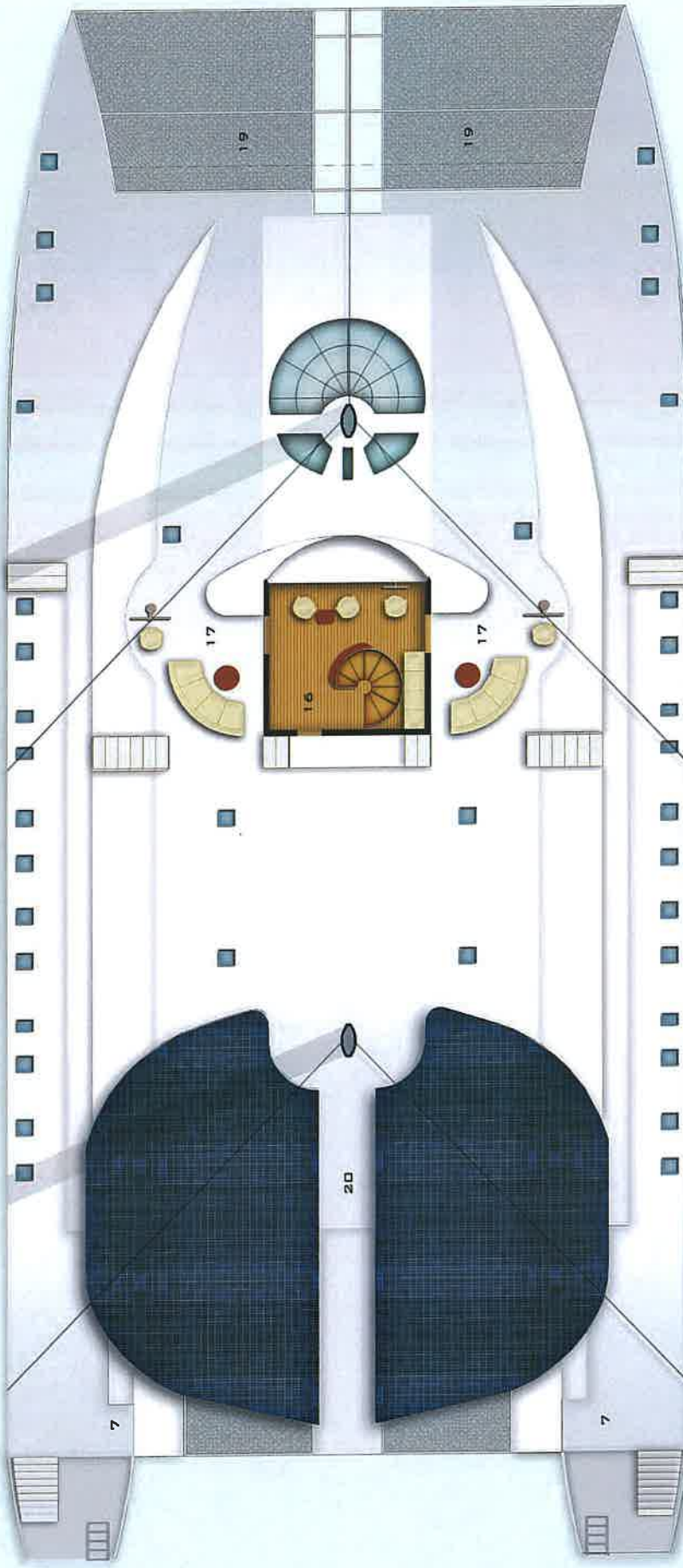
PARCAS 120
